Physical activities can involve the use of equipment for Personal Training, Assisted/ facilitated Yoga practices and/or Bodywork. I also accept responsibility for any social and economic loss might result not only from my own actions, but also from the actions, inactions or negligence of others, or the condition of the premises or equipment used in connection with such activities. Nevertheless, I agree to assume the risk of injury, damage, or loss regardless of severity that I, my minor/ward/guest or other family member or guest may sustain as a result of the activities I engage in for Yoga, Personal Training, and Bodywork services provided by the Brandon Massage Studios, LLC. and /or Yoga Blessings.Org

Accordingly, **I agree to waive, relinquish, discharge, release, and covenant not to sue Brandon Massage Studios, LLC, or Yoga Blessings. Org**, or its parent, sister, affiliated and/or subsidiary, corporations and related entities, their members, owners, officers, directors, partners, employees, consultants, contractors, advisors, agents, insures, attorneys and volunteers, from any and all rights, claims of injury, demands, causes of action, damages, liabilities or loss that I, my minor/ward/guest, or other family member may have or that may accrue to me, my minor/ward/guest, or other family members arising out of, connected with, or in any way associated with the services provided by the Brandon Massage Studios LLC. and/or Yoga Blessings.Org.

Notwithstanding the foregoing and any other provision of this Agreement, I do not waive any rights that I may seek redress due to the reckless conduct of others or due to the conduct of others, which is both intentional and wrongful.

I have considered that if this Agreement were not as broad as it is, the cost of Personal Training, Yoga practices and / or Bodywork services provided to me and/or my minor/ward/guest, by Brandon Massage Studios and/ or Yoga Blessings. Org, would be considerably higher and I do not wish to pay considerably higher cost. By signing this Agreement, I waive the right to bargain for different terms in this Agreement. I also understand that if I later learn that any fact that I believed to be true at the time I signed this Agreement is later to be found incorrect, I nevertheless a bound by this Agreement.

In no event, shall we be liable for any cause of action, claim, damage, demand, expense, fine, investigation, liability, or penalty in excess of the amounts that you paid to us in the preceding 12 months, whether one time or in the aggregate.

You agree to defend, hold harmless, and indemnify us for any of your negligent or reckless acts or omissions. You warrant and represent that you have no medical or other condition, which would prohibit you from participating in any of our programs that you have registered for.

This Agreement constitutes the entire agreement between the Parties on the issues contained in this Agreement and supersedes all prior agreements and/or memoranda. This Agreement may only be modified in writing with the written consent of both Parties. This Agreement is intended to bind only the Parties hereto, and their successors, and may not be assigned by either Party without the express written consent of the other.

This Agreement shall be governed by the laws of the State of Florida. All Parties irrevocably consent that the venue and jurisdiction of any dispute shall lie in Hillsborough County, Florida. In the event that a court determines that any provision of this Agreement is invalid, all other provisions shall survive and the Agreement shall be interpreted to fulfill the intent of the Parties as shown in this Agreement.
